Warrick County Solid Waste Management District (Owner) is requesting Bids for the construction of the following Project:

Phase 2 Electrical Upgrade Material Recovery Facility Automation Project

Bids for the construction of the Project will be received at the **the office of Warrick County Solid Waste Management District** located at **1111 S. Pelzer Road, Boonville, IN 47601** until **November 20, 2025 at 12:00 P.M.** local time. At that time the Bids received will be **publicly** opened and read.

The Project includes the following Work:

This project will include electrical power upgrades to the newly installed and upgraded Recycling Center equipment. The installation of the automated sorting system has required additional electrical power and power distribution equipment, including but not limited to, raceways, conduits, wiring, switchboards, panelboards and an upgraded exterior transformer by CenterPoint. There are no building modifications anticipated other than those required for mounting and installing the previously mentioned equipment.

Bids are requested for a single prime Contract.
