General Notice

The City of Anderson (Owner) is requesting Bids for the construction of the following Project:

DRY WEATHER PUMP STATION AND FORCEMAIN REHABILITATION

Bids for the construction of the Project will be received at the **City of Anderson Board of Public Works** located at **120 East 8th Street, Anderson, IN 46018**, until **Tuesday, January 13, 2026 at 1:15 pm** local time. Bids received will be **publicly** opened and read aloud as part of the scheduled Board of Public Works meeting which begins at 1:30 pm.

The Project includes the following Work:

CIPP lining 3,600 linear feet of 36" force main, installation of new dry weather pumps at Dewey Street Pump Station, wet well top slab reconstruction, existing building demolitions, electrical upgrades, and monorail crane installation.

Bids are requested for a single prime Contract.

Bidding Documents may be downloaded from the designated website. The designated website will be updated periodically with addenda, lists of registered plan holders, reports, and other information relevant to submitting a Bid for the Project. All official notifications, addenda, and other Bidding Documents will be offered only through the designated website. Neither Owner nor Engineer will be responsible for Bidding Documents, including addenda, if any, obtained from sources other than the designated website. **Following registration, complete sets of Bidding Documents may be downloaded from the Issuing Office's website as "zipped" portable document format (PDF) files. The cost of printed Bidding Documents from the Issuing Office will depend on the number and size of the Drawings and Project Manual, applicable taxes, and shipping method selected by the prospective Bidder. Cost of Bidding Documents and shipping is non-refundable. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of the Bidding Documents will not be available from the Issuing Office.**

A non-mandatory pre-bid conference for the Project will be held on **Thursday, December 18, 2025 at 9:00 am at Dewey Street Wastewater Treatment Plant, 2104 W 8th Street, Anderson, IN 46016**. This pre-bid conference will be held at the pump station site.

Instructions to Bidders

For all further requirements regarding bid submittal, qualifications, procedures, and contract award, refer to the Instructions to Bidders that are included in the Bidding Documents. Bid security, in a sum of not less than five percent (5%) of the total amount of the highest aggregate bid, shall be furnished in accordance with the Instructions to Bidders. **The Owner reserves the right to reject any and all Bids in whole or in part as specified in the solicitation when it is not in the best interest of the governmental body as determined by the purchasing agency in accordance with IC 5-22-18-2. The Owner also reserves the right to waive irregularities in any Bid, and to accept any Bid, which is deemed most favorable to the Owner.**

The Contractor must submit an affirmative action plan in addition to the Bid pursuant to City of Anderson Ordinance 38.10. Any bid may be withdrawn prior to the scheduled closing time for receipt of Bids, but no bidder shall withdraw his Bid within 60 days after the bid opening.
